



DID YOU KNOW...

- NEW EDITION OF THE PILOT'S HANDBOOK OF AERONAUTICAL KNOWLEDGE RELEASED.
 - The 2023 edition reflects the latest aviation industry procedures, equipment, techniques, regulations, and National Transportation Safety Board (NTSB) recommendations and is a key reference in the FAA Airman Certification Standards (ACS), according to ASA officials, who note that changes include updates to drugs and the impact on flight, non-towered airport operations, and attitude indicator pitch and bank limitations.



REMINDERS FOR THE UPCOMING WEEK

- Last minute cancellations are running amok! If you need to cancel, the window is 18 hours. Any last-minute cancellations need to be routed through your CFI or the office (voicemail if after hours). FSP will not let you delete the reservation within 18 hours of the flight. Per the rental agreement, the policy states:
 - If aircraft and/or CFI is scheduled and cancellation notice is not given within eighteen (18) hours prior to the scheduled time, there will be a one-hour minimum charge for the aircraft and/or CFI.
