


**BEN ROLLER -COMMERCIAL PILOT**

## **HEAD'S UP**



Exact location and times may change. Pilots planning to fly in this region should check published NOTAMs frequently... before every flight!

Previous TFRs in this region have resulted in numerous airspace violations.

We need your help in getting the word out:
Please pass this information along to as many pilots and aviation professionals as possible

The procedures contained in this alert describe a typical Security TFR. Check the published NOTAMs for any changes or unique procedures. Several types of operations will be prohibited during this event. The published NOTAM will have specific details.

Inner Core: Usually a 10NM ring or rings. There may be multiple rings at different locations. General aviation is not permitted to operate within the Inner Core.

Outer Ring: From inner core to 30NM. Depending on location of inner rings there may be multiple outer rings. IFR and VFR flights are permitted as long as they are on a flight plan, squawking a discrete beacon code and talking to ATC. You may land or depart airports within the outer ring and fly through the outer ring as long as you follow the appropriate procedures. You shouldn't loiter within the TFR for any reason.

The FAA, the Department of Defense and other federal agencies will be closely monitoring and

patrolling this airspace looking for violators.

Airport operators, managers and flight schools, please post this notice as widely as possible. If you know of an event planned for this weekend please check the published NOTAM to see if there is a conflict.

FROM: Scott Gwiazda, Airport Duty Manager -Airport Operations SUBJECT: RAMP FREEZE and TFR - PRESIDENTIAL VISIT

The President of the United States is visiting the Reno-Tahoe area on Monday, 3/18/2023.

Air Force 1 is expected to arrive at approximately 5:20 PM local time and depart at approximately 7:15 PM local time.

A TERMINAL FLIGHT RESTRICTION (TFR) is expected to be in effect 30 minutes prior to arrival Monday 3/18/2023 for airspace within a 30 nautical mile radius of RNO.

The arrival RAMP FREEZE will commence 15 minutes prior to his arrival, approximately 5:05 PM, and will extend until after the President departs the airfield

The departure RAMP FREEZE will commence 15 minutes prior to the President returning to the airfield, at approximately 6:50 PM, and extends until the aircraft departs.

During the RAMP FREEZE, no foot, vehicle, or aircraft traffic will be allowed on the main terminal ra in or around the concourses, or on the FBO ramps. SIDA doors, roll-up doors, vehicle gates, and GA hangar doors must remain closed during the Ramp Freeze. Construction activities, if any, in the Airport Operations Area must cease; equipment must remain stationary and drivers must exit vehicles and go indoors or remain inside vehicles with doors closed and windows up.

Violators may have badges or proximity cards confiscated and may be subject to questioning by

We will make every effort to minimize the ramp freeze duration, but all staff and tenants must adhere to the procedures in effect during the ramp freeze.

The Airport Communications Center will conduct notification for the Ramp Freezes via phone, radio, and mass notification.
